TODAY'S NEWS

Pada Kamis (23/11) Rupiah dibuka di level 15,590/15,610 dengan *first traded* di 15,610, dengan kurs acuan JISDOR di level 15,593 (*prior*: 15,584). Rupiah bergerak pada *range* 15,550 – 15,620. Perdagangan Rupiah hari ini akan dipengaruhi oleh PMI *Composite* Eropa tercatat mengalami perbaikan meski masih berkontraksi di level 47.1 (*prior*: 46.5 ; *surv*: 46.9) yang merupakan dampak dari perang Rusia-Ukraina yang berkepanjangan. Hal tersebut berbanding terbalik dengan PMI *Composite* Inggris yang berekspansi di level 50.1 (*prior*: 48.7 ; *surv*: 48.7) didorong oleh investasi teknologi serta penguatan belanja umum. Dari dalam negeri, melalui hasil Rapat Dewan Gubernur BI (RDGBI), suku bunga acuan BI *7-Day Reverse Repo Rate* (BI7DRR) dipertahankan di level 6.00%, suku bunga *Deposit Facility* tetap 5.25% dan suku bunga *Lending Facility* sebesar 6.75%. Gubernur BI, Perry Warjiyo mengatakan, keputusan ini konsisten dengan kebijakan stabilisasi nilai tukar rupiah dari dampak tingginya ketidakstabilan global.

Global Market

PMI *Composite* Eropa tercatat mengalami perbaikan meski masih berkontraksi di level 47.1 (*prior*: 46.5 ; *surv*: 46.9) dampak dari perang Rusia-Ukraina yang berkepanjangan. Hal tersebut berbanding terbalik dengan PMI *Composite* Inggris yang berekspansi di level 50.1 (*prior*: 48.7 ; *surv*: 48.7) ditopang oleh investasi teknologi serta penguatan belanja umum untuk pelayanan bisnis di negara tersebut. Dari China, *People's Bank of China* (PBOC) diperkirakan akan menahan suku bunga di level 2.50% setelah pertumbuhan ekonomi China diproyeksikan mencapai 5.20% di akhir tahun ini dan 4.50% di tahun 2024. Selain itu, pemerintah China berencana untuk mendorong sektor infrastruktur yang mengalami perlambatan melalui pinjaman sebesar USD 500 Miliar dari sektor perbankan China melalui pinjaman tanpa agunan. Selain itu, pemerintah China berupaya mencari pendanaan dari luar untuk sektor infrastruktur dan mendorong pertumbuhan ekonomi China dengan target 5.20% pada akhir tahun ini dan 4.50% pada tahun 2024.

Domestic Market

Berdasarkan hasil Rapat Dewan Gubernur BI (RDGBI), suku bunga acuan BI *7-Day Reverse Repo Rate* (BI7DRR) dipertahankan di level 6.00%, suku bunga *Deposit Facility* tetap 5.25% dan suku bunga *Lending Facility* sebesar 6.75%. Gubernur BI, Perry Warjiyo mengatakan, keputusan ini konsisten dengan kebijakan stabilisasi nilai tukar rupiah dari dampak tingginya ketidakstabilan global serta sebagai Langkah *pre-emptive* dan *forward looking* untuk mitigasi dampak inflasi barang impor. Sementara itu, untuk mendukung pertumbuhan ekonomi yang berkelanjutan, kebijakan makroprudensial terus ditempuh melalui penguatan implementasi Kebijakan Insentif Likuiditas Makroprudensial (KLM) dan menurunkan rasio Penyangga Likuiditas Makroprudensial (PLM) untuk mendorong pembiayaan dunia usaha.

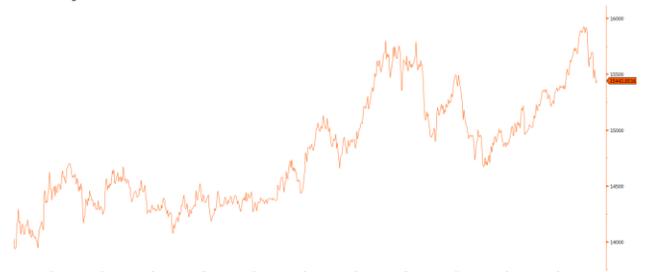

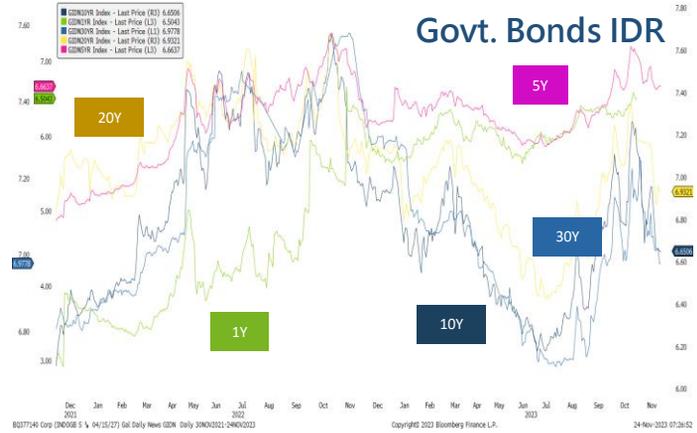

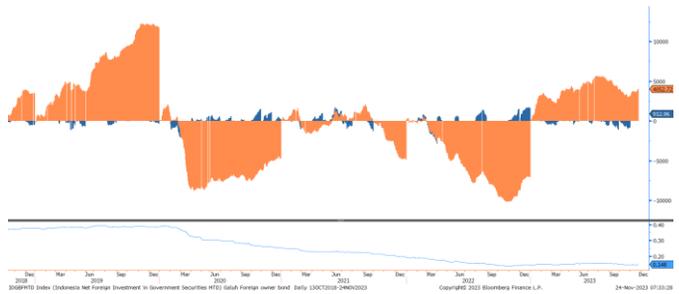
